- Preparing the inventor declaration and claim for priority, power of attorney, and assignment documents (from the inventors to the company), forwarding the completed documents (in your choice of format) for execution,
- Receiving and reviewing the executed documents to verify accuracy and completeness,
- Preparing a preliminary amendment to remove multiply dependent claims and address minor formal matters,
- Preparing the initially required Information Disclosure Statement of all references cited in any International Search Report and any references forwarded by the applicant that are initially considered to be material to patentability,
- Preparing all formal documents required for filing, including the Initial Data Information and Transmittal documents,
- Filing of all application documents by the priority deadline (same day available if received by 1 pm local time) with our daily courier to the offices of the US Patent and Trademark Office or electronically (as USPTO infrastructure and systems permit),
- Confirming the filing of the documents to you by facsimile and email, with copies of all filed documents sent upon filing or after receipt of the application serial number, and
- Reviewing and forwarding the official filing receipt and recorded assignment by your choice of email, facsimile or conventional postal mail.

Our current fee for the Level 1 Filing Program is **\$750** (fixed) plus expenses (current U.S. governmental filing fees, translation costs, draftsman's charges, photocopies, postage, and facsimile charges).

For those clients who desire a higher degree of attorney review and revision of their U.S. priority or national phase applications, Roylance, Abrams, Berdo & Goodman has a *Level 2 Filing Program* that includes the following services in addition to those in our *Level 1 Filing Program*:

- More detailed review of the specification documents to include minimum compliance with U.S. substantive disclosure requirements (utility, enablement, support of the claimed invention), a comparison of the claimed invention against the scope of the disclosure, and suggestions for additional claims. Clients are asked to forward the application in electronic format to facilitate review and revision. If required, we will arrange for a translation of the priority specification and forward it for client review and approval.
- 48 Hour, expedited review, revision, return for inventor review, and filing are available for a modest surcharge.

Our current fee for the Level 2 Filing Program is **\$1500** (fixed) plus expenses.
